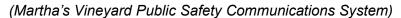

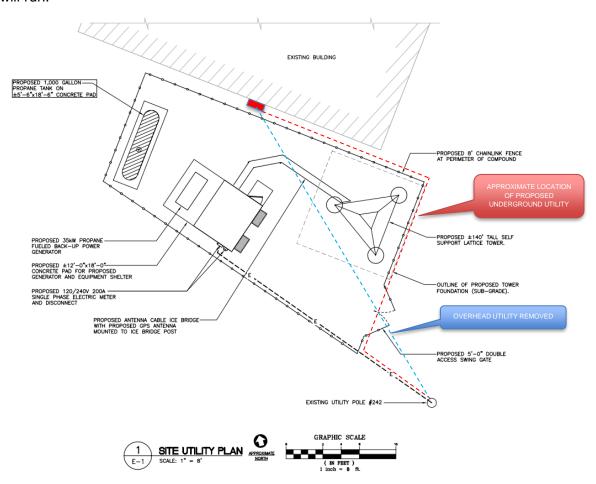

OAK BLUFFS HIGHWAY DEPARTMENT UNDERGROUND UTILITY PHASE 1B - FY2020

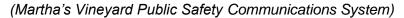
Summary:

In order to mitigate interference and enhance the resilience of the Oak Bluffs Highway Department tower, it was necessary to remove an existing overhead utility service. This line provided regular utility power to the Oak Bluffs Town Highway Departments salt/equipment shed. As the bulk of construction at this site is completed, it is necessary to trench and provide an underground utility conduit between the Eversource pole and shed. The costs associated with this project are outside of the development grant Phase 1B funding and would fall under Development Contingencies Reserve budget line item. Attached below is a modified excerpt of the original construction drawings showing the approximate location in which the conduit and feeder will run.

MAINTENANCE ORDER #4 DCR FIRE TOWER STRUCTURE ENHANCMENT

PHASE 1B - FY2020

Summary:

As part of the lease agreement with the Department of Conservation and Recreation (DCR), a condition is imposed to remove and clear brush around the site. During the initial design of the system, we were able to incorporate this into our grant application and received approval in order to expand the compound and install our additional equipment. Additionally, DCR requested that we also **replace the stair treads and associated hardware going up the tower**.

This cost is outside of the development grant funding and would fall under the maintenance budget line item - Development Contingencies Reserve, subsection 'unknown site lease costs'. We have received an estimate from Brahmin Builders to complete this work. By subcontracting this portion of the project, we will reduce the cost approximately 50%, as compared to contracting Motorola Solutions for this portion of required work. Its amount below \$10,000 threshold complies with the Massachusetts Sheriffs Association Procurement Rules, used by DCSO.

Attached below is a highlight excerpt from our lease agreement terms with DCR showing the condition to complete the work listed above. Also included with this maintenance order is a copy and statement of work from Brahmin Builders to complete this work.

COMMONWEALTH OF MASSACHUSETTS DEPARTMENT OF CONSERVATION AND RECREATION HIGH GROUND SPECIAL USE PERMIT ISSUED TO DUKES COUNTY SHERIFF'S DEPARTMENT FOR USE OF THE INDIAN HILL FIRE TOWER, WEST TISBURY, MARTHA'S VINEYARD, MASSACHUSETTS

This High Ground Special Use Permit ("Permit") is issued by the Commonwealth of Massachusetts acting by and through its Department of Conservation and Recreation with a principal place of business located at 251 Causeway Street, Suite 600, Boston, Massachusetts 02114 ("DCR") to Dukes County Sheriff's Department, P.O. Box 252, 149 Main Street, Edgartown, Massachusetts 02539 (hereinafter "Permittee").

PURPOSE

The purpose of this Permit is to allow the Permittee to place new equipment on the DCR Fire Tower and install exterior equipment cabinets and generator as shown on Exhibit A, attached hereto and incorporated herein by reference (the "Premises"), located on land in the care, custody and control of DCR on and at the Fire Tower at Indian Hill, West Tisbury, Massachusetts.

AUTHORITY

The DCR issues this Permit pursuant to the authority set forth in G. L. c. 132A, §§ 2D and 7, c. 92, §§ 33 and 37, and DCR's rules and regulations promulgated under titles 302, 304 and 350 of the Massachusetts Code of Regulations, and all other powers enabling.

TERM

The Term of this Permit commences as of September 1, 2019, and expires on August 31, 2029, unless sooner terminated in accordance with the provisions of this Permit.

2. FEES

a. Permittee shall pay to DCR an annual fee as reflected in chart below:
